
<u>Methodology</u>

Questionnaires were hand-delivered to all 614 occupied households in Acomb Parish and included a link to an online version.


Any household that was unable to respond online could have a paper questionnaire collected by A4A volunteers.

Q4a Were you aware of Acomb Voluntary Support Network during Covid-19 Pandemic? (Tick, as applies)








Q4g Did you know where to go for assistance? (Tick, as applies)





Q6b If Yes, are you satisfied with the available Broadband speed in your home and/or on your mobile device? (Tick, as applies)





Q6c As a consequence of lockdown, are you a new user of the Internet and/or social media? (Tick, as applies)







Were all locals consulted or is it just an opinion of a few? What actual evidence exists of accidents or injuries over the years? In my experience, G. H. Bank has a very safe history and the issue below needs reviewing. Having 3 monstrous closely spaced humps on G.H. Lane is over-kill, causing drivers unnecessary problems. They are too high and aggressively shaped to be negotiable going up such a steep hill and should be significantly lowered or removed. On the uphill approach of the one at the bottom of the hill, in particular, it's necessary to lose virtually all momentum to crawl over it without causing damage to the car which means having to fight to regain enough movement to continue upwards requiring virtually a hill start. The middle one is not much better. This should not be happening. It's a 20mph limit not a 2mph limit., which is clearly marked on the road surface. These types of speed bumps are appropriate for larger, more level roads used by heavy commercial vehicles but are excessive on a steep lane, mostly used by cars. Even the heavily used A6079 at the bottom of the lane only has a brick rumble strip. There would be opposition to putting 3 of these closely spaced humps there and it is a level surface.




Q14b Would you like more cycle trails within Acomb Parish? (Tick, as applies)




