Aiming to be a community that supports the needs of its 21st Century residents in a sustainable way that protects and enhances the rural character of Acomb Parish.

WHAT IS THE COMMUNITY LED PLAN (CLP)?

The CLP is a working document formed by the views of the community of Acomb. It aims to point the way towards meeting the needs of the community to achieve lasting and sustainable benefits for Acomb residents and businesses.



Its objectives are:

- To focus on what is important to the people living and working in Acomb Parish
- •To identify possible ways to address a wide range of social, economic and environmental issues identified within the community
- •To provide a clear action plan for the community of Acomb to work in partnership with the Parish Council and County Council, local interest and user groups, such as Action4Acomb and the WI, and external bodies as required. (e.g. Environment Agency)

Achievement of these objectives will enable the community of Acomb to influence decision makers, deliver projects, secure funding as well as bringing local people together with a common purpose.

Action4Acomb (A4A) was established to create, monitor and review the CLP in partnership with other key organisations such as the Parish Council. The previous Community Led Plan (CLP) covered a five-year period and expired in 2020. However, the impact of covid restrictions delayed the work necessary to revise and refresh the plan. A new village wide survey has now been undertaken, the findings of which have been fed back to residents through a series of open meetings. It is now possible to roll the plan forward.

For the CLP to be meaningful and lead to successful outcomes for the community, effective partnerships need to exist, principally between the key groups and bodies involved in its delivery. Partners have been consulted on the contents of this plan and have contributed to its details.

Most importantly, this plan represents the views and opinions of the people of Acomb. They have had a voice through a Parish-wide questionnaire and the availability of several open-door events in advance of the final launch of this CLP.

While the aims and ambitions expressed in this plan are not binding on any individual or group, it should be remembered that these are reflections of the views and ambitions of Acomb residents.

However, there remains a significant need for people to volunteer their time, expertise and energy to help fulfil the future aspirations of Acomb. Each of the many groups and activities currently taking place across the village depend on this.





Significant changes to Acomb since the last CLP was produced:

- Loss of Post Office and shop
- Completion of Birkey Heights & the infill development behind The White House
- Reduction in bus services post-pandemic

The Cornerstone of the Acomb CLP

The responses to the 2021 survey suggest that the three pillars of the first CLP still hold true:

- 1. Protect and Sustain (the natural and historic environment)
- 2. Improve and Renew (infrastructure)
- 3. Support and Co-Operate (*Community spirit* and engagement)

87% of respondents to the 2021 questionnaire said that the surrounding countryside was the main reason they liked living in Acomb, as well as village life and the proximity to Hexham.

Therefore, there is a need to continue to:

- Monitor any developments/plans that may threaten the rural nature of the village or conservation area
- Protect and enhance the countryside and heritage around us
- Sustain the cornerstones of village life and vitality
- Encourage residents and visitors to care for the local environment
- Improve connectivity with Hexham both for non-car users and to reduce car borne journeys
- Find ways to further support the growing number of home workers

Among the active groups in the village that can contribute in their different ways are:

- Parish Council and Trustees
- Action4Acomb
- Acomb Women's Institute

The three cornerstones of village life remain true as Acomb looks to its future:

PROTECT AND SUSTAIN

To preserve and conserve the natural environment of Acomb, to enhance habitats and biodiversity, and meet the climate emergency; to better understand the historic environment of Acomb and the measures needed to protect it.

SUPPORT AND CO-OPERATE

To maximise the benefits of cultural activity to the social and economic wellbeing of the community; to further the contribution of young people to the community.

IMPROVE AND RENEW

To maintain and enhance facilities and services, encouraging networking, and improving communications and promotion; to improve the economic viability of shops and businesses in Acomb in order to enhance the socio-economic sustainability of the village; to determine a housing policy for Acomb, based on current and future needs, both of the community and of the environment; to promote and campaign for a functioning and integrated transport system, suitable for the 21st century and the environment, with an emphasis on the needs of a rural community.

These are some of the things people said about improvement and renewal for Acomb:

"Access to Hexham is very important for services and transport."

"Getting the bus to Hexham is hard as the transport has been reduced."





"Speeding traffic past the school, especially large farm vehicles/It is scary that cars speed up Main Street/Far too much traffic up and down Garden House Bank/Since speed bumps on Garden House Bank, traffic down Orchard Avenue is really bad!"

"Crossroads at north end of village needs improvement. Visibility for pedestrians and traffic is atrocious"

"The A6079 through Acomb and towards the A69 needs resurfaced as it is very uneven with potholes and becoming dangerous. Additionally the edges and hedges are overgrown which makes visibility poor, especially at the bottom of Garden House Bank where the signposts are fully covered by hedges and shrubbery."

"I think some of the footpaths bordering the very busy A6079 are inadequate in terms of width for pedestrians, and this means that residents and pedestrians are potentially at risk from traffic."

"The road end out of Millersfield is lethal to both drivers and pedestrians alike."

"Since the speed bumps installed in Garden House Bank a lot of traffic using Main Street, Orchard Avenue and round the Methodist Chapel now."



"Drains ... need to be kept clear so water can enter drains before it gets into village."

"Problem areas include: inadequacy/poor maintenance of road drains and gullies to deal with surface water flooding, especially in extreme rainfall events. Identification of vulnerable residents who would need assistance in the event of a flood. Delays in the development of natural flood management in the upper catchment."





A4A as the Steering Group for the CLP recommends that groups and individuals report back on different aspects of the Plan on an annual basis so that progress can be formally monitored and the action plan be reviewed and updated as needed.

Finally, it is recommended the Plan is subject to full revision every ten years.

APPENDIX OF ABBREVIATIONS, ORGANISATIONAL DESCRIPTIONS and CONTACTS

APC: Acomb Parish Council A4A: Action4Acomb CCSC: Climate Change Sub-Committee EA: Environment Agency EVA: Environmental Volunteers Acomb

ACOMB PARISH COUNCIL: A parish council has statutory authority to make decisions on behalf of the people in the parish and has an overall responsibility for the well-being of its local community. It is the level of government closest to the community and is invariably the first place people will go with concerns or ideas. For this reason they are a vital part of any community. Their work falls into three main categories: representing the local community, delivering services to meet local needs and striving to improve quality of life in the parish. Parish Councils raise their funding through a portion of the overall Council Tax households pay annually; this is known as a 'Precept'.

Climate Change Sub-Committee: A sub-committee of the Parish Council tasked with contributing to NCCs overall target of becoming Carbon Neutral by 2030.

Local Transport Plan: APC contributes through NCC to the Regional Transport Plan outlining the future maintenance and development of transport issues across the North East. **Acomb Neighbourhood Plan**: Acomb's NP is a statutory part of the decision-making process for land allocations and planning application decisions made at local level.

ACTION4ACOMB: A constituted not-for-profit community group established to steer the production of a Community Led Plan. Although not a statutory body, A4A is able to apply for external funding to assist in taking forward projects or activities that will contribute to furthering objectives in the CLP.

ENVIRONMENTAL VOLUNTEERS ACOMB: The combined groups of the School Common Action Team and the Acomb Footpath Group. Their work includes making Rights of Way reports to NCC, doing small scale interventions to improve Public Rights of Way in and around Acomb, and working with Acomb First School and Little Oaks Nursery to ensure the School Common is suitable for Forest Schools and other outdoor education.
